Ltd at Mumbai Corporate Business Office-3, 1<sup>st</sup> floor, NCL Premises, Plot C-6, Bandra East, Mumbai- 400051 based on the prebid meeting it has been decided to issue an addendum to the existing RFP as follow

1. The bidder to ensure that Work shall not be carried out from 9.00a.m. to 7.30p.m. from Monday to Saturdays. On Sunday work can be carried out full day.
2. On 2nd and 4th Saturdays work can be done for full day subject to no member raises any objection regarding noise.
3. All debris to be collected in the basement and duly dispatched after NIA convenience
4. Heavy vehicles bringing raw materials like cement, sand bags etc for unloading will only be permitted inside the premise before 9.00 a.m. or after 7.30 p.m Whereas on 2nd and 4th Saturdays and Sundays they will be allowed any time of the day.
5. All Workmen shall register their respective names with the security in lobby. After 10.00p.m. if work is carried out bidder may need special permission from B.K.C. Police station.
6. Under no circumstances will the workmen be allowed to use Lifts
7. All unloading should take place behind next to Society garden.
8. Cleanliness to be strictly taken care whilst loading and unloading of raw materials in compound as well staircases.
9. An amount of Rs 25,000/- to be deposited by the bidder, issued in the name of the Society which is refundable and will not be presented. It is towards security towards any damaged caused whilst work is carried out.
10. Any liaison with the authorities related to the job work should be managed solely by the bidder.
11. Bidder to ensure that the workmen on duty obey orders from security and maintain cleanliness in the Society.
12. Bidder to ensure that all water taps are closed in the night by the workmen and there is no wastage of water.
13. While the work is carried out office will be functional as usual. The bidder to install temporary wooden partition on the site at their own cost so that the office work is not hampered.
