Additionally, bidders are required to attach self-attested copies of the necessary documents as outlined.
2. Failure to do so will result in the automatic termination of the contract, and the complete amount paid by the buyer, including Security Money and Earnest Money Deposit, shall be forfeited as a consequence of the breach of contract by the purchaser.
10. Purchasers are kindly requested to adhere to all safety regulations and instructions provided by the Seller at the time of material lifting.
