### 8. Collection & Disposal/Recycling of Material

- Lifting of all scrap from "as is where is" basis will be the total and complete risk and responsibility of scrap purchaser only.
- The buyer should follow the procedure of NIACL with regard to entry of vehicle, issue of material in force at the time of taking delivery. Cost of segregation / cutting / bundling / loading / unloading / transportation etc. of scrap materials are to be borne by the buyer
- All statutory requirements including environment, health, safety and labour enactments should be strictly followed in respect of persons employed by the buyer(s).
- The buyer shall be solely responsible for proper disposal/recycling of the items by fulfilling the prevalent Environment Laws/compliances.
- The buyer's representatives, workers, lorry drivers and others will have to strictly observe
- the working hours and regulations regarding the discipline and security while they are inside the premises of NIACL. Any violation of the regulation regarding discipline and security may lead to forfeiture of Security Money and termination of the contract by NIACL at her discretion.
- The selected bidder must not indulge in any corrupt or unlawful practice while executing the work. If any such case is reported and established, NIACL will have full rights to forfeit the Security Money and cancel the contract.
