#### GENERAL RULES & INSTRUCTIONS FOR THE GUIDANCE OF TENDERER

- The New India Assurance Company Ltd, Regional Office, Ernakulam, Reserves the Right to Accept or reject any or all Tenders or split the work between more than one bidders without assigning any reason or without any prior notice thereof.
- 2. Tenderers are accepted to visit the site before quoting the rates and should satisfy themselves as to the nature and conditions of work and facilities available etc.
- The Tenderers are required to examine the Tender form and conditions mentioned in the Tender.
- 4. The Tenderers should quote the rates in figures. The amount for each item should be worked out and the requisite total shall be given.
- 5. The total amount shall be written both in figures and words.
- The rates quoted in this Tender shall be for measured finish works and shall include all charges including cost of all materials, transportation, freight charges, sales Tax or any other applicable taxes etc., complete.
- 7. The work is to be completed within 30 days from the date of issue of acknowledged work order.
- 8. The successful Tenderer shall give all necessary personal attention to the work during the progress of work, and also until the expiry date of "DEFECTS LIABILITY PERIOD" which is 12 Months.
- 9. The Company reserves the right to reject any portion of work or materials which is found unsatisfactory and not up to the standard.
- 10. A Tax deduction at Source (T.D.S.) at applicable rates will be done from payments to Contractors and the same will be paid to Income Tax Department and certificates of TDS will be paid to the Contractors.
- 11. Sales Tax or any other tax on materials in respect of this contract shall be payable by the Contractor and Company will not entertain any such claims.

#### CONDITIONS OF CONTRACT

**NOTE:** The requirements of these conditions shall be fulfilled by the Tenderer without extra charges, the item rates quoted shall be deemed to have taken these conditions into account.

- 1. The term Company means The New India Assurance Company.
- 2. If any addition and alterations are found necessary, the Tenderer will have to do the same within the Tendered rates with the approval of the Company.
- 3. The Contractor shall employ adequate labour to complete the work within the scheduled time and shall make his own arrangements for storing materials etc. The Contractor shall have to make his own arrangements to house his labour and staff, and for their services.
- 4. All Tendered rates shall include for the cost of materials, labour, supervision, tools, plant, transport, all taxes, contingencies duties, breakages, wastages, sundries, scaffolding etc., complete.
- All instructions regarding the execution of works shall be received from the Company only. Any other instructions issued directly to the Contractor by anyone else shall not be binding on the Company.

- The Company, shall have the power to omit or cancel, any item of work without assigning any reason whatsoever and no claim for compensation for damage will be entertained for such omissions and cancellations.
- 7. The Tenderer shall maintain satisfactory progress of work as well as maintain a desired level of workmanship. If in the opinion of the Company the progress is unsatisfactory or the workmanship is unsatisfactory, the Company to take possession of the work with 4 days to that effect. The Company shall then complete the entire work and rectify all the defects at the Contractors cost and consequences.
- 8. In case the Company are not satisfied with the quality of materials used by the Tenderer, they reserve the right to direct the Contractor to procure such supplies from agencies they deem fit.
- 9. The Tenderer is responsible for clearing any dirt, rubbish & superfluous materials as they accumulate and everything unnecessary & to leave the Premises in a clean and orderly condition on completion and fit for occupation. No extra payment shall be made for doing this.
- 10. Any work which is not approved by the Company shall have to be removed within 24 hours from the time of order and shall have to be redone by the Tenderer at his own cost and this cost will be borne by the Company.
- 11. No deviation whatsoever for any reason will be permitted. However, if any deviation becomes necessary, the same should be brought to the immediate notice of the Company and written approval must be obtained for such deviation before proceeding with the execution of work.
- 12. The Company has got the right to supply any materials required for the work and the cost of the materials so supplied will be deducted from the bills of the successful Contractor.
- 13. The Contractor shall be responsible for the safe custody of the materials issued to him by the Company till they are used for the work. He shall make his own arrangements for the safe custody and proper storage and preservation in sound conditions till the same are actually used in the work.
- 14. For items other than mentioned in the Tender document, the Company as per prevailing fair market rate, shall fix the rate, which will be binding on both the Company and the Contractor.
- 15. The Tenderer shall have a competent supervisor who should invariably be available at the site during progress of work and during working hours.
- 16. In case the Brand of materials mentioned in the Tender is not available in the market, the alternate materials to be used shall be approved by the Company. Necessary cost adjustments will be made in the rate, if required by the Company.
- 17. All other materials that will be used for the work shall be of best quality as specified in the Bureau of Indian Standards.
- 18. The Contractor shall be given a single electrical connection at the work site. Arrangement for the water shall be made by the Tenderer.
- 19. The Contractor should strictly adhere to the specifications and Brand of the materials, mentioned in the annexure. Any such deviations done without bringing it to the notice of Company will be rejected and NOT QUALIFY for payment.
- 20. Any clarification on the specifications or further details needed, are made available from the RO Estate and Establishment Dept.
- 21. In case the Contractor executes the work of certain items at their workshop or at any other places, they shall inform the Company before and get the approval of the same from them.

- 22. The Company will not be bound to accept the Lowest Tender and reserves the right to accept or reject any or all the Tenders without assigning any reason whatsoever.
- 23. The successful tenderer shall inform the Company of the work if the Tendered quantity increases more than 25%.
- 24. Time shall be the essence of this contract and the contractor shall commence the works immediately upon agreement and finish the work in the stipulated 30 days.
- 25. The successful tenderer shall be ready to carry out works between non-Company working hours and even at nights and Sundays or other holidays.
- 26. The tenderer shall extend full co-operation to the other contractors / agencies who are also working for the same project and coordinate with them in finishing the awarded work.
