


The SC/ST/OBC candidates' caste certificate will be verified through proper channel. If the verification reveals that the claim of the candidates to belong to SC/ST/OBC as the case may be is false, the candidature of such candidates will stand cancelled and services of such candidates, if appointed, will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.

OBC candidates are required to produce non-creamy layer certificate in the required format. Certificate should contain the "Non-Creamy Layer Clause" based on the Income for the financial year ending 31.3.2018 and should be issued on or after 01.04.2018 and should be valid as on the date of application.

If the verification reveals that the claim of the candidates to belong to Other Backward Classes or not to belonging to the Creamy Layer is false, his / her candidature will stand cancelled and if appointed, services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
